1. NOMINATIONS WILL BE ACCEPTED ONLY AFTER RECEIPT OF THE MANAGERS WRITTEN APPROVAL OF THE NOMINATION IN THE SPACE PROVIDED. (Part B)
2. ALL NOMINATIONS MUST INCLUDE THE NAMES, ADDRESSES TELEPHONE NUMBERS, AVERAGES AND SIGNATURES OF ALL TEAM MEMBERS. AT LEAST FOUR (4) OF THE NOMINATED BOWLERS MUST BOWL ON THE FIRST DAY.
3. IF ANY OF THE NOMINATED BOWLERS WITHDRAW THEIR NAME FROM A TEAM, OR THE TEAM IS UNABLE TO FIELD FOUR (4) OF THE NOMINATED BOWLERS ON THE FIRST DAYS PLAY FOR ANY REASON, **PLEASE CONTACT THE INTERDISTRICT CHAIRMAN ON 02 47 356 114.**
4. AVERAGES TO BE USED ARE INTERDISTRICT AVERAGES FOR 2018, OVER A MINIMUM OF 18 GAMES AS AT 18<sup>th</sup> NOVEMBER 2018 AND WILL BE SUBJECT TO CONFIRMATION.
5. IF NO 2018 INTERDISTRICT AVERAGE OVER 18 GAMES, THEN THE HIGHEST 2018 LEAGUE OR TOURNAMENT AVERAGE (REGARDLESS OF AFFILIATION) OVER A MINIMUM OF 18 GAMES MUST BE USED, INCLUDING THOSE THAT HAVE FINISHED IN THE LAST THREE (3) MONTHS AND IS SUBJECT TO CONFIRMATION.
6. AFTER INTERDISTRICT HAS COMMENCED, THE ENTERING AVERAGE OF NEW TEAM MEMBER NOT ON THE ORIGINAL NOMINATION FORM, MUST NOT RAISE THE TEAMS AVERAGE ABOVE THE DIVISIONAL CUT-OFF OF 975 OR 880 ON ANY GIVEN DAY'S BOWLING. (THIS INCLUDES ROVING RESERVES).
