Code of Conduct

All bowlers are to uphold the InterDistrict Tournament Rules and the Code of Conduct.

CONDUCT THAT WILL NOT BE TOLERATED

1. Failure to observe the InterDistrict Tournament Rules – copies of these are available from the web at: <https://interdistrict.com.au/> or from their Divisional Secretary or the InterDistrict Co-ordinator.
2. Bowlers who do not respect the rights, dignity and worth of other bowlers.
3. Any form of abuse or intimidation of other bowlers within the InterDistrict Tournament or members of the InterDistrict Tournament Committee.
4. Abuse of Bowling Centre machinery or equipment or other bowler's equipment.
5. Abuse of Centre staff members or spectators.
6. Foul language.
7. Drug abuse
8. Drunken behaviour

PENALTIES THAT MAY BE APPLIED TO BREACHES OF THE CODE OF CONDUCT

First Offence: The offender will be given an official warning by their InterDistrict Secretary.

Second Offence: The penalty for a second offence is possible suspension from the InterDistrict Tournament or penalties as described within the InterDistrict Tournament Rules (refer Chapter 5 – General Conduct and Chapter 17 - Violations).

COMPLAINTS

Every bowler will have the right to appeal their case before the InterDistrict Committee. Any bowler wishing to make a complaint or appeal must do so in writing within **24 hours** of the alleged event to their Divisional Secretary.
